# Privacy Notice

## How we use parent/carers information

This Privacy Notice provides information on how we process information in accordance with the Data Protection Act 2018 and the General Data Protection Regulation (GDPR).

### 1. Data processing

Data processing of personal data means any activity that involves handling the information, such as collecting, storing, sharing and destroying such personal information.

### 2. The categories of information that we process include:

- personal information (such as name, address, national insurance number, emergency contact information, email address)
- Bank details for the collection of payments
- Family characteristics, such as ethnicity, spoken languages, eligibility for free school meals, or special educational needs
- Relevant legal information
- Details of any support received, including care packages, plans and support providers (for example information to support eligibility for free school meals)
- CCTV images captured on the premises

The above list is not exhaustive but are the main examples of the type of information. We may also hold data we have received from other organisations, including other schools, local authorities, the NHS and other similar agencies.

### 3. Why we collect and use this information

We collect and use this data for the following purposes:

- a) to enable the normal service delivery of the organisation
- b) to assess the quality of our services
- c) safeguarding children and adults
- d) to meet statutory regulations
- e) send you reports and updates related to your child/children
- f) send you information about related events and to obtain consent for specific activities
- g) contact you in the case of an emergency
- h) administer the admissions process

The above list is not exhaustive but are the main examples of why we use the information.

### 4. The lawful basis on which we process this information

Under the General Data Protection Regulation (GDPR), the lawful bases we rely on for processing

personal information are:

- Legal obligation – we process certain information to comply with the law
- To protect vital interests – such as the individual’s life
- Contractual obligation – to fulfil the obligation of providing an educational service
- Specific consent is provided
- Legitimate interest – in order for the school to carry out its normal services
- Public task or interest – this is set out in law or in the exercise of ‘official authority’

In addition, concerning any special category data (such as information on race or religion), the lawful bases are:

- Specific consent being provided
- Legal obligation
- To protect vital interests
- Carried out in the course of legitimate activities with appropriate safeguards
- Relates to personal data which are manifestly made public by the subject (individual)
- Necessary for the establishment, exercise or defence of legal claims
- Necessary for substantial public interest
- Necessary for the purposes of preventative or occupational medicine
- Necessary for public interest in the area of public health
- Necessary for archiving in the public interest, scientific or historical research purposes or statistical purposes

## **5. Collecting the information**

We collect personal information via a number of ways, such as application forms and other professional or government agencies.

Whilst the majority of personal information you provide to us is mandatory, some of it is requested on a voluntary basis. In order to comply with GDPR, we will inform you at the point of collection, whether you are required to provide certain information to us or if you have a choice in this.

## **6. Storing the information**

We hold data securely for the set amount of time as according to our data retention schedule and in order to comply with legal obligations. For more information on how we keep your data safe, please refer to our Data Protection Policy and data retention schedule.

## 7. Why and who we share the information with

We do not share information about you with anyone without consent unless the law and our policies allow us to do so. All data is shared in a secure manner.

Where we are legally required to do so, or as permitted to do so by law, we may share this information with:

- the local authority (where applicable)
- the Department for Education (DfE)
- other central or local government departments or agencies (such as to enquire about eligibility for free school meals, social care)
- the police, courts or tribunals (where applicable)
- other educational establishments
- other professional bodies
- other agencies when requested by law
- suppliers and service providers (to enable them to provide the service we have contracted them to undertake on our behalf)

Information will be provided to those agencies securely or anonymised where possible.

The recipient of the information will be bound by confidentiality obligations, we require them to respect the security of your data and to treat it in accordance with the law.

## 8. Requesting access to your personal data

Under data protection legislation, you have the right to request access to information about you that we hold. You can also make a request with respect to your child's data where the child is not considered mature enough to understand their rights over their own data (usually under the age of 13), or where the child has provided consent.

You also have the right to:

- object to processing of personal data that is likely to cause, or is causing, damage or distress
- prevent processing for the purpose of direct marketing
- object to decisions being taken by automated means
- in certain circumstances, have inaccurate personal data rectified, blocked, erased or destroyed; and
- a right to seek redress, either through the ICO, or through the courts

**The right to object only applies in certain circumstances. The Trust and its schools have the right to process data in order to fulfil its legal obligations as described in Sections 3 and 4. In these instances, the right to object does not apply.**
